

‘Lifetime Flyaway Contest to Watch Ellen 2019’ **Contest Terms and Conditions**

TERMS AND CONDITIONS

By submitting an entry to the Contest,

(a) all participants (“**Contestants**”) agree to be bound by these Terms and Conditions, which are deemed to include any further instructions provided by the Organisers which may be set out in the Contest website(s) and/or any Contest application(s) (if applicable). Any Contestant and Winner (hereinafter defined) who fails to abide by any of these Terms and Conditions may be disqualified at the sole discretion of the Organiser.

(b) Contestants agree to receive publicity, marketing, promotional and advertising materials (“**Marketing Materials**”) from Organiser and its affiliated companies. If the Contestant wants to stop receiving Marketing Materials, Contestants should follow the unsubscribe instructions in the Marketing Materials.

(c) Contestants agree that the Winner of the Contest including their designated travel partner shall consent to (i) the public disclosure of their personal details and particulars including his/her name, image, appearance and any photographs submitted for the Contest and/or the Show (hereinafter defined) for publicity or commercial purposes; (ii) participate in the publicity and promotional activities of Organiser in relation to the Contest and/or the Show; and (iii) the use by Organiser of any information or data provided by the Winner for any future marketing efforts or other promotional purposes of the Organiser in any media, without further notice or compensation by the Organiser and AETN Indemnified Parties (hereinafter defined). Entry into the Contest and acceptance of the Prize shall be deemed as consent on the part of the Winner (and their travel partner, where applicable) for this purpose.

Contest: *'Lifetime Flyaway Contest to Watch Ellen'* is an online contest organised by the Organiser to fly TWO (2) winners (and a plus one each) to Los Angeles to watch the live taping of the *Ellen DeGeneres* show ("Show").

NOTICE: All Contestants, Winners and his/her Travel Partners agree and acknowledge that the running of the Contest, awarding and/or fulfilment of the Prize shall be SUBJECT to and CONTINGENT upon the Organiser receiving the Show's live taping tickets in respect of Clause 8A(i) below by Warner Bros. Entertainment Inc. and/or the Show's producers/organiser(s). The Organiser and/or Warner Bros. Entertainment Inc. and/or the Show's producers/organiser(s) reserve the sole and absolute right to withdraw, suspend, postpone, forfeit, cancel and/or to no longer make available the Show's live taping tickets for the Contest and/or as part of the Prize, at any time without prior notice and in such an event, the Organiser reserves the sole and absolute right to withdraw, suspend, postpone, forfeit, cancel and/or to no longer make available the Prize under the Contest without any prior notice and without any liability or compensation to you and/or your Travel Partner by the Organiser and/or AETN Indemnified Parties (hereinafter defined) in any manner whatsoever.

1. (a) Eligibility Criteria

The Contest is open to residents of Brunei, Cambodia, Fiji, Hong Kong, Indonesia, Laos, Macau, Maldives, Mongolia, Myanmar, Papua New Guinea, the Philippines, Singapore, Taiwan, Thailand and Vietnam and the Contestant must be **above 18 years** of age as of the commencement of the Contest Period. Contestants below the age of 18 years are not eligible to participate. The Organiser has the absolute discretion at any time to determine the eligibility of any Contestant and reserves the right to disqualify any Contestant without any obligation to give any reason whatsoever.

1. (b) Ineligibility

(i) Employees, representatives, servants, agents, sponsors, licensors, advertising or promotion agencies, suppliers of materials, prizes and services related to the Contest and/or the Show and/or other service providers of the Organiser (and its affiliated and related companies); and (ii) employees representatives, servants, agents, sponsors, licensors, advertising or promotion agencies, suppliers of materials, prizes and services related to the Contest and/or the Show and/or other service providers of Warner Bros. Entertainment Inc. (and its affiliated and related companies), (iii) any other third party which is involved in organising, promoting or conducting the Contest and/or the Show including any third party associated with the Organiser's Lifetime channel/services and/or the Organiser's media business and operations; and (iii) as well as their immediate family members (parents, step-parents, legal guardians, children, step-children, siblings, step-siblings), their legal or common law spouse, and any persons residing with these employees, representatives, agents, sponsors, licensors, advertising or promotion agencies, suppliers of materials, prizes and services related to the Contest and/or the Show and/or other service providers of the Organiser (and its affiliated and related companies) and of Warner Bros. Entertainment Inc. (and its affiliated and related companies) and of any other third party which is involved in organising, promoting or conducting the Contest and/or the Show are NOT eligible to participate in the Contest and/or win the Prize. For avoidance of doubt, "employees" under this provision shall include all freelancers, interns, consultants, contractors and any part-time personnel(s).

2. Charges

Contestants are not required to pay or make any purchase in order to participate in this Contest.

Any internet charges incurred while participating in the Contest is the Contestant's responsibility and is dependent on the Internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows a Contestant to automatically enter repeatedly is prohibited and will render all entries submitted by that Contestant invalid.

3. Contest Period

The Contest shall be held from **[25 March] 2019 to [15 April 2019] 5PM (Singapore time) 2019 (“Contest Period”)**.

The Organiser reserves the right to vary, postpone or re-schedule the Contest Period or any dates thereof at its sole and absolute discretion. Submissions received before the commencement of the Contest Period and after the stipulated Entry Deadline (as defined below) will not be considered by the Organiser.

4. Entry Deadline

Contestants must submit all entries before **5pm (Singapore time) on [15 April 2019]**.

5. Contest Language

The Contest will be run by the Organiser in English.

6. Entry/Submission Procedure

During the Contest Period, the Organiser will post the Contest details and terms and conditions on www.lifetimeasia.com/contest/ellen (the “**Website**”).

To participate in the Contest, the Contestant shall have to ensure he/she does the following during the Contest Period:

(i) Contestant shall be required to provide the Organizer with their following particulars along with their submission / entry for the Contest:

- Name;
- Age;
- Contact Number;
- Country of Residence/Address;
- Email Address;
- Are you a Lifetime channel/service subscriber?
- Pay television operator and their pay television subscriber number/ID in their country of residence.

(ii) Contestants are required to have a valid and authenticated pay television subscription account to the Organiser's "Lifetime channel/service" under their pay television operator in their country of residence;

(iii) Contestants are required to watch the Show on the Organiser's Lifetime channel/service;

(iv) Contestant will be required to answer (i) which guest interview did he/she enjoy the most and why; and (ii) why does he/she want to watch the Show i.e. The Ellen DeGeneres Show live in Los Angeles?

(v) Contestants have to login to the Website, and submit their answer(s) to the abovementioned question(s) on the Website; and

(vi) Contestants are allowed to submit one (1) entry each.

All details and particulars submitted must be true, original works, accurate and complete, and may be verified by the Organiser. Any incomplete or incorrect information found in the entry will result in the disqualification of the entry.

Once submitted, all entries become the absolute property of the Organiser. Contestants who wish to withdraw their participation in the Contest thereafter can submit a written request to the Organiser at lifetimeasia@aenetworks.com. The Organiser accepts no responsibility for any entries that are lost, illegible, incomplete or altered and all such entries shall be disqualified. Confirmation of sending an entry via the Internet is not proof of entry nor does it constitute receipt.

The Organiser reserves the right to reject/disqualify any entries that contain any obscene, profane, offensive, lewd, pornographic or otherwise inappropriate information or material, and to decline publication of any photograph(s) uploaded, or to edit any content or description which is deemed to be obscene, profane, offensive, lewd, pornographic or otherwise inappropriate. The Organiser is under no obligation to enter into discussion with any Contestant over their entry submission.

7. Selection of Winner

Two (2) winners will be selected based on the quality and creativity of the entry submitted (each collectively, the “**Winner**”).

The Contest is a game of skill and not of chance and all Contestants must use their knowledge, skill and creativity in order to win.

The Winner of the Contest shall be determined by the Organiser in its sole discretion, and its decision shall be final. No correspondence or discussion will be entered into with Contestants concerning the results. In selecting the Winner of the Contest, the timing of his/her response/answers would be based on what appears on the Website as viewed at the Organiser’s end, and the Organiser’s decision is in this regard final and conclusive. The Organiser reserves the right to select another winner in its sole discretion if it has reasonable grounds to believe that the selected Winner has breached or contravened any of these Terms and Conditions.

8. Prizes and Fulfilment

(A) Each Winner of the Contest will be entitled to the following prize of a [**four (4) day/three (3) night**], trip to Los Angeles to watch the Show’s live recording (the “**Trip**”) consisting of the following only:

(i) **TWO (2) tickets passes** only for the Winner and his/her one (1) travel partner to attend the live taping of the Show on a date which shall be determined solely by the Show’s producers and/or organiser(s);

(ii) **TWO (2) return economy class air tickets to Los Angeles** (“LA”) only for the Winner and his/her one (1) travel partner, departing from the capital state of the Winner’s country of residence (as submitted by the Winner via their Contest entry during the Contest Period) irrespective of which state/city/province the Winner and his/her travel partner is residing in their country of residence (for example, for purpose of illustration only, if the Winner selected is from Thailand, the departing ticket(s) shall be from Bangkok only);

(iii) **Three (3) nights only twin sharing hotel accommodation** in LA for the Winner and his/her one (1) travel partner. The Organiser shall only be responsible for providing the hotel room only in accordance with the terms hereunder and shall not be responsible for any other charges incurred pursuant to the Winner and his/her travel partner's stay at the hotel (e.g. room mini bar, room service etc.); and

(iv) Cash allowance for the Winner and his/her one (1) travel partner: **Per diem rate of [US\$250 cash per person] for three (3) days** only for miscellaneous expenses (for example, meals, transport); and (ii) **[US\$100 cash per person]** for airport transfer. Save for such allowance in cash to the Winner and his/her travel partner which shall be capped at a total amount of **[US\$850] per person** only, and there shall be no reimbursement and/or any claim(s) by the Winner himself/herself and the Winner shall ensure that his/her travel partner has no claim(s) for all or any expenses incurred by the Winner and/or his/her travel partner whatsoever associated with all or any part or fulfilment of the Contest, Prize and/or the Show.

hereinafter collectively referred to as "**Prize**"

(B) The Winner agrees and acknowledges that he/she shall comply and shall ensure the Winner's designated Travel Partner ("**Travel Partner**") shall comply with the following terms and conditions associated with the Prize:

(i) **Age criteria for Travel Partner:** The minimum age criteria for the Travel Partner shall be **18 years and above**, as of the commencement of the Contest Period. The Organiser and/or the Show's producers/organiser(s) have the absolute discretion at any time to determine the eligibility of any Winner and/or their Travel Partner and reserves the right to disqualify any Winner and/or their Travel Partner without any obligation to give any reason whatsoever.

(ii) The Winner shall ensure that his/her Travel Partner, with respect to fulfilment of the Prize, shall be subject to and comply with the Term and Conditions hereunder (where applicable) including but not limited to the obligation to indemnify the Organiser and AETN Indemnified Parties arising from his/her Travel Partner's participation or their breach in connection with the Contest or fulfilment of the Prize

(including compliance with the eligibility criteria for the age, travel and visa requirements) hereunder. Any breach of such compliance to the Terms and Conditions by the Winner's Travel Partner may result in disqualification of the Winner and/or forfeiture of the Prize (wholly or a part thereof) immediately by the Organiser in its sole discretion.

(iii) The Winner and his/her Travel Partner agrees and acknowledges that

(a) The awarding and/or fulfilment of the Prize shall be subject and contingent to the Organiser receiving the Show's live taping tickets in respect of Clause 8A(i) above by Warner Bros. Entertainment Inc. and/or the Show's producers/organiser(s). The Organiser and/or Warner Bros. Entertainment Inc. and/or the Show's producers/organiser(s) reserve the sole and absolute right to withdraw, suspend, postpone, forfeit, cancel and/or to no longer make available the Show's live taping tickets for the Contest and/or as part of the Prize, at any time without prior notice and in such an event, the Organiser reserves the sole and absolute right to withdraw, suspend, postpone, forfeit, cancel and/or to no longer make available the Prize under the Contest without any prior notice and without any liability or compensation to the Winner and/or his/her Travel Partner by the Organiser and/or AETN Indemnified Parties (hereinafter defined) in any manner whatsoever; and

(b) The Show's live taping tickets and its fulfilment is solely subject to the Show's recording schedule and availability which shall be determined in the sole and absolute discretion of the Show's producers/organiser(s). Such tickets shall be subject to black-out dates, change, postponement and/or cancellation at any time without prior notice by the Organiser and any such change, postponement and/or cancellation of the Show's live taping tickets may result in the Prize (either wholly or partly) to be changed, modified, postponed, cancelled and/or forfeited accordingly at the sole discretion of the Organiser without prior notice.

(iv) As a precondition to being awarded and accepting the Prize, the Winner agrees and acknowledges that he/she shall attend, and shall ensure that his/her Travel Partner shall attend and be present for the full duration of the Show's live taping during the Trip. In the event of such failure

for any reason whatsoever (either wholly or partly where both or either one do not attend the Show's live taping), the Contestant agrees to indemnify (i) Organiser (ii) the Show's producers/organiser(s) including Warner Bros. Entertainment Inc.; (iii) any and all advertising, marketing, travel, event and/or sponsorship partners of the Organiser, and/or (iii) each of their related companies (including parents, subsidiaries and affiliates), licensors, licensees, successors, assigns, distributors and/or agents ("AETN Indemnified Parties") against all claims, damages, liabilities, costs and expenses, loss (including but not limited to any indirect and/or consequential damage or loss) arising out of the non-fulfilment of the Prize (either wholly or partly) and non-compliance with Terms and Conditions hereunder. **Without prejudice to any claim(s) or action(s) that the Organiser and any of AETN Indemnified Parties may have hereunder, the Winner agrees and acknowledges that upon demand from the Organiser, he/she shall immediately reimburse and/or return all Prize(s) (where applicable) received as the Winner under the Contest and to procure the same from his/her Travel Partner including but not limited to refunding all cash allowance(s) received by the Organiser pursuant to Clause [8A(iv)] above.**

(v) The Winner and his/her Travel Partner must hold a valid passport and be eligible to apply and obtain all required visas required for travel to Los Angeles, USA prior to departure from their country of residence.

(vi) The scheduling and/or fulfilment of the Prizes are subject to the Show's live taping recording schedule and availability, flight, and/or hotel availability and the Organiser reserves the right to black-out dates (if applicable) and the Winner and their Travel Partner shall not be entitled to change, cancel or re-schedule the flight and hotel dates, departure & arrival country booked by the Organizer and/or the Show's live taping scheduled dates, for any reason whatsoever. The Organiser shall not be responsible for any delays in flights (including any connecting/transit flights) and/or hotel check-in which may affect the Show's live ticket scheduled date and/or Prize itinerary.

(vii) The airline carrier, air ticket class and connecting/transit flight layovers, airport departure/arrival location(s) and hotel selections are at the sole and absolute discretion of the Organiser and may be changed at any time without prior notice.

(viii) The Winner shall be solely responsible for (a) the payment of any and all applicable costs and other additional charges where applicable for him/her and their Travel Partner; and (b) for complying and ensuring that he/she and their Travel Partner complies with all laws, regulations and rules associated with their consumption of the Prize by the Winner and his/her Travel Partner including but not limited to taxes, travel visas, travel and health/medical insurance, airport/tariff taxes/foreign duties (as applicable in the country of entry or departure), all domestic travels in their county of residence to arrive/depart from the designated airport, all and any charges incurred at the hotel (save for the room), excess baggage, any health or other Government and/or any of the Show's producers/organiser's and/or any of the Organiser's affiliate partners/sponsors requirements associated with the Contest, Prize and the Show.

(ix) The Prize is only redeemable subject to the Show's live taping tickets availability (wherein such tickets availability shall be determined solely by the Show's producers and/or organiser(s)), flight and/or hotel availability. The Winner agrees and acknowledges that

(a) Organiser is not responsible or liable including any delay, postponement, forfeiture and/or cancellation of any or all of the Prize and that the Show's live taping ticket dates and availability (including whether such ticket(s) are meant for a live or recorded version of the Show) shall be determined solely by the Show's producers/organiser(s);

(b) In the event of any such delay, postponement, change, forfeiture and/or cancellation of any or all of the Prize (including but not limited to the Show's live taping tickets dates and availability), and the Organiser is unable to provide the stated Prize either wholly or partly, the Organiser reserves the absolute right in its sole discretion to change, modify, substitute, forfeit and/or cancel the Prize for any reason whatsoever without prior notice; and

(iii) In addition, the Winner(s) and their Travel Partner of the Contest hereby releases and agrees to indemnify and hold harmless the Organiser against any and all costs, liabilities, expenses, damages, demands or disputes arising out of or in connection with the non-fulfilment (either wholly or partly) of all or any of the Prize including any delay, postponement, change, and/or cancellation of the Show's live taping tickets date(s).

(x) The Winner shall not order any goods, services or incur any liability on behalf of nor pledge the credit of the Organiser and/or any of the Show's producers/organiser(s) and/or the Organiser's affiliate partners/sponsors associated with the Contest, Prize and Show.

(xi) The Prize is as stated and is non-transferable, non-refundable, non-upgradeable, non-combinable, non-mileage accruable and cannot be exchanged for cash, other services, credit or any other benefit in-kind, and will not be valid for travel on the abovementioned black-out dates (if applicable). If due to circumstances beyond the Organiser's control, the Organiser is unable to provide the stated Prize either wholly or partly, the Organiser reserves the right to change, postpone, substitute, delay, modify or cancel the Prize (wholly or any part thereof) for any reason whatsoever without prior notice.

(xii) The Prize may be subject to third party terms and conditions including but not limited to the Show's producers/organiser's and the Organizer's associated partners/sponsors for which the Organiser is not responsible or liable including any delay, postponement, cancellation and/or for any or all the Prize warranties and conditions of the subject matter of the Prize including any collection, use and disclosure of the Winner's and their Travel Partner's personal data.

(xiii) Prior to receiving the Prize and/or attending the Show,

(a) the Winner and his/her Travel Partner may be required to sign one or more liability and publicity release form(s) either by the Organizer, Warner Bros. Entertainment Inc., and/or the Show's producers/organiser(s) and/or its affiliated partners/sponsors of the Prize, which could include, amongst other things, a Statement of Eligibility and Liability/ Publicity Release by Warner Bros. Entertainment Inc., a written acknowledgement of acceptance of all the Terms and Conditions of the Contest and further terms and conditions of the Prize and/or the Show, and a release of liability and failure to sign such release as instructed by the Organiser and/or all or any of the AETN Indemnified Parties to comply with the Terms and Conditions herein may, at the sole discretion of the Organiser, result in disqualification of the Winner and his/her

Travel Partner from the Contest and/or the forfeiture of the Prize (either wholly or any part thereof) immediately; and

(b) The Winner acknowledges and accepts that they and their Travel Partner have read and understood and agree to be bound by such third-party terms and conditions including but not limited to Warner Bros. Entertainment Inc., the Show's producers/organiser's and the Organizer's associated partners/sponsors in relation to each Prize including but limited to their participation and attendance at the Show's live recording session and any such liability and publicity release documentation(s) as instructed by Warner Bros. Entertainment Inc. and the Show's producers/organiser(s).

(xiv) By participating in this Contest, attending the Show and by redeeming your Prize as a Winner (if applicable), the Winner and their Travel Partner are also subject to Warner Bros. (xv) Organiser, the Show's producers/organiser(s) and all other affiliated partners, sponsors and associated entities are not liable for any damage, loss, accident, injury and/or any inconvenience (including but not limited to any indirect and/or consequential damage or loss) arising in any way that may be suffered by, or caused to Winner and his/her Travel Partner and their properties in conjunction with the fulfilment of Prize including but not limited the fulfilment of the Show's live taping tickets nor for any changes in dates/times, delay or cancellations which may prevent the Winner and their Travel Partner from accepting and/or consuming the Prize offered or any part thereof of the Prize.

9. Notification of the Winner

The Winner of the Contest will be contacted by the Organiser and subsequently announced via the Website (the "**Notification**"), and such Winner shall be allocated the Prize at the sole discretion of the Organiser.

The selected Winner will be required to respond to the Organiser acknowledging receipt of the Notification within [**24 hours**] of Notification and such response shall

include the provision of particulars required by the Organizer for verification purposes with respect to the Winner's submission of their Contest Entry, for example, the provision of the Winner and his/her and their Travel Partner's passport details, availability and confirmation to travel for the Trip at such dates designated by the Organiser in its sole discretion and any other information required by the Organizer for purposes of fulfilment of the Prize , failing which, that Winner will be deemed to have forfeited the Prize and the Organiser will proceed to select another winning entry.

Personal Data Sharing. The Winner and his/her Travel Partner consent to the Organizer sharing their personal data, particularly such data he/she provides during the Contest entry and during the Notification with the Show's producers/organiser(s) and their affiliated partners (including Warner Bros. publicity and promotional materials and events related to the Contest, the Show and/or the Prize and/or for any other purpose on any websites, microsites, social media pages and/or on-air on any of the television channel(s) owned and/or operated by (i) Organiser; (ii) the Show's producers/organiser(s) including Warner Bros. Entertainment Inc.; and (iii) any and all advertising, marketing and/or sponsorship partners of the Organiser, and/or (iv) each of their related companies (including parents, subsidiaries and affiliates), licensors, licensees, successors, assigns, distributors and/or agents, throughout the world in perpetuity.

Each Contestant hereby releases and shall procure for his/her Travel Partner to release (i) Organiser, (ii) the Show's producers/organiser(s) including Warner Bros. Entertainment Inc.; (iii) any and all advertising, marketing and/or sponsorship partners of the Organiser, and/or (iv) each of their related companies (including parents, subsidiaries and affiliates), licensors, licensees, successors, assigns, distributors and/or agents,, from any and all claims that the Contestant may at any time have in connection with the use of such materials including without limitation, any and all claims for libel and/or invasion of privacy, infringement of any intellectual property or other rights.

Each Contestant represents and warrants that the materials submitted with their entry do not infringe any intellectual property rights (including, but not limited to, copyrights) or other rights of any third parties and each Contestant agrees to indemnify and hold harmless (i) Organiser; (ii) the Show's producers/organiser(s) including Warner Bros. Entertainment Inc.; (iii) any and all advertising, marketing and/or sponsorship partners of the Organiser, and/or (iv) each of their related companies (including parents, subsidiaries and affiliates), licensors, licensees, successors, assigns, distributors and/or agents,, against all claims, damages, liabilities, costs and expenses arising out of the use of such materials related to the Contest, the Show and/or the Prize.

12. Privacy Notice

Organiser will collect each Contestant's personal information submitted when entering the Contest, as required in accordance with these Terms and Conditions.

Organiser may use this personal information to properly administer the Contest and/or Prizes, including use in a publicly available winners list (if applicable).

You acknowledge and agree that any personal data and/or information you post on the Website in the course of your participation in the Contest and during the Show would constitute publicly available information and you consent to the Organizer's and/or the Show's producers/organiser(s) including Warner Bros. Entertainment Inc.'s use and/or license others to use such data or any part thereof in any and all media, whether now known or hereafter devised, for editorial, advertising, promotional and/or marketing purposes of the Organiser and/or the Show's producers/organiser(s) including Warner Bros. Entertainment Inc. without further compensation to you except where prohibited by law.

Organiser will use each Contestant's personal information as explained in these Terms and Conditions and/or to properly administer and provide the Prize. 13. Release and Indemnity
